BANA MEMBERSHIP



BANA will function as a Federation of RWAs with Welfare Associations of Apartment Complexes, Residential Layouts and 'Gated Communities' as their members

Extension of Membership to Individuals & Commercial Establishments will be considered by the Governing Council in Office after processes are set, initial goals are achieved & BANA is ready to expand

Executive Committee (EC) - 7 Members

Governing Council (GC) - 17 Members

EC/GC MEMBER ELIGIBILITY

TERM LIMIT - One year extendable to three

- **Should be a member of one of the RWAs registered with BANA**
- **Should have passion & dedication to contribute to the cause and above all, integrity**

1 or 2 GC Members lead each SC

General Member(s) to lead SC in addition to GC Member

A GC Member OR General Member cannot be part of more than 2 committees

FORMATION OF AOP

- Association of Persons (AOP) is setup to run the activities of BANA till 30-JUN-2012
- 3 member's among the AOP are identified as signatorial authorities

FORMATION OF SOCIETY / TRUST

- Incorporate Society/Trust by 31-MAR-2012
- General Body will approve and pass the resolution to incorporate Society/Trust
